PRE-APPLICATION Requirements **must** be met by all applicants and appropriate transcripts attached for validation at the time of application:

Any student who fails to maintain a 2.5 curricular GPA and a 2.0 cumulative GPA will automatically void any nursing application status including acceptance.

I understand that if I do not include the required college/university transcripts with my nursing application, that my nursing application will be incomplete, and will not be processed.
