To be eligible for a GEER scholarship, you must be a dislocated worker who is enrolled in an eliqible stackable credential program for six or more credits per term, eliqible for Title IV (federal) aid, domiciled in Virginia, and have an Expected Family Contribution (EFC) of 12,000 or less as calculated by the FAFSA.
